Subject: Occupational Health & Safety Report – 3rd Quarter 2015

Summary:

As indicated in the chart below, for the three months ending September 30, 2015 there were 18 first aid incidents which required on site attention by Exhibition Place staff (i.e. bandage for small cuts), 12 recordable medical aid incidents which required attention by a physician at a hospital or doctor's office, and 1 lost time injury.

Financial Impact:

There are no financial implications to this report.

Decision History:

The Exhibition Place 2014 - 2016 Strategic Plan had a Safety and Security Goal to promote safe work practices for all staff and as a Strategy to support this Goal we will implement programs and procedures designed to achieve "zero" lost time injuries.

Issue Background:

Pursuant to the *Occupational Health & Safety Act*, section 25(1) and 26(1), the Board as the employer is responsible for taking every precaution reasonable for the safety of the workers. Also, as a local board of a municipality, the Board is a Schedule II employer for the purposes of workers compensation.

18 First Aid incidents, 12 recordable Medical Aid incidents and 1 Lost Time injury.


