Subject: 2017 Rental and Services Price List

# Summary:

This report recommends approval of the Rentals and Services Pricing for 2017 as outlined in the Confidential Attachment I. A comprehensive review and update of the price list is done annually to factor in the increase in labour and material costs to assure a competitive return to the Board on show services offered. Generally the increases that are being recommended either reflect directly the increase in general labour rates associated with the supply of the service or increases that are in keeping with the market place surveys that were undertaken.

# **Recommendations**:

#### It is recommended that the Board:

- 1) Approve the Show Management Price List for third party Rentals and Services, outlined in the Confidential Attachment, effective January 1, 2017; and,
- 2) Direct that the confidential information contained in the Confidential Attachment not be released publicly, except to Show Management upon execution of a License Agreement, in order to protect the competitive position and the future economic interests of Allstream Centre, Enercare Centre, and Exhibition Place.

### Financial Impact:

There are no negative financial implications resulting from the adoption of this report which proposes a 2017 Rentals and Services cost that reflect market values and increases in labour and material costs that affect Exhibition Place operations.

# **Decision History**:

The Exhibition Place 2014-2016 Strategic Plan had a Financial Goal to *Effectively Monitor Costs* and Revenues and as a Strategy to support this objective we will Ensure Operating Budgets are met or Show a Positive Surplus to Budget.

At its meeting of May 22, 2015 the Board approved the third-party rentals and services price list for 2016. ### Issue Background:

A comprehensive review and update of the master price list is done annually in conjunction with the commencement of the Operating Budget process as the price of services impact show revenues and ultimately the 2017 Operating Budget. In addition, the Sales & Marketing and

Event Management Services Divisions are already providing quotes to shows for 2017 and therefore, the need to have updated rates for these quotes.

The Finance & Audit Committee were scheduled to meet on Friday, June 24, 2016 to consider subject report, however, the meeting needed to be cancelled for lack of quorum. Given the 2017 Rental & Price List for the Board is required as part of the 2017 Operating Budget, it is being submitted directly to the Board.

### Comments:

The Confidential Attachment 1 is the proposed Price List for Rentals and Services which staff are recommending be adopted effective January 1, 2017. The price list was compiled by a staff team and the prices being recommended have been compared to other service providers in the industry. It is intended that some of the pricing from this list will also be used, where applicable, to the Allstream Centre Program although given the unique events in Allstream, services are provided often as an overall package pricing to meetings/conferences.

The Confidential Attachment provides prices that have also been reviewed to factor in the increase in labour costs to assure a competitive return to the Board on services offered. On an ongoing basis the services and cost of services are monitored to evaluate their profitability and competitiveness in the market place. Generally the increases that are being recommended either reflect directly the increase in labour rates associated with the supply of the service or increases that are in keeping with the market place surveys that were undertaken. For the information of the Board, where there is a price change for 2017 it is noted in the respective columns. If there is nothing noted in the "change" column then it means the price for 2017 is the same as in 2016.
