Subject: Occupational Health and Safety Report –1st Quarter 2016

Summary:

As indicated in the chart below, for the three months ending March 31, 2016 there were 5 first aid incidents which required on site attention by Exhibition Place staff (i.e. bandage for small cuts), 2 recordable medical aid incidents which required attention by a physician at a hospital or doctor's office, and zero lost time injuries.

Recommendation:

It is recommended that the Board receive this report for information.

Financial Implications:

There are no financial implications to this report.

Decision History:

The Exhibition Place 2014 - 2016 Strategic Plan had a Safety and Security Goal to promote safe work practices for all staff and as a Strategy to support this Goal we will implement programs and procedures designed to achieve "zero" lost time injuries.

Issue Background:

Pursuant to the *Occupational Health & Safety Act*, section 25(1) and 26(1), the Board as the employer is responsible for taking every precaution reasonable for the safety of the workers. Also, as a local board of a municipality, the Board is a Schedule II employer for the purposes of workers compensation.


- <u>Frequency</u> = # of lost time injuries X 200,000 / total hours worked
