Subject: **Occupational Health and Safety Report – 1<sup>st</sup> Quarter 2015**

## Summary:

As indicated in the chart below, for the three months ending March 31, 2015 there were 3 first aid incidents which required on site attention by Exhibition Place staff (i.e. bandage for small cuts), 5 recordable medical aid incidents which required attention by a physician at a hospital or doctor's office, and 1 lost time injury.

## Financial Implications:

There are no financial implications to this report.

## Decision History:

The Exhibition Place 2014 - 2016 Strategic Plan had a Safety and Security Goal *to promote safe work practices for all staff* and as a Strategy to support this Goal we will *implement programs and procedures designed to achieve "zero" lost time injuries.*

## Issue Background:

Pursuant to the *Occupational Health & Safety Act*, section 25(1) and 26(1), the Board as the employer is responsible for taking every precaution reasonable for the safety of the workers. Also, as a local board of a municipality, the Board is a Schedule II employer for the purposes of workers compensation.

3 First Aid incidents, 5 recordable Medical Aid incidents and 1 Lost Time injury.

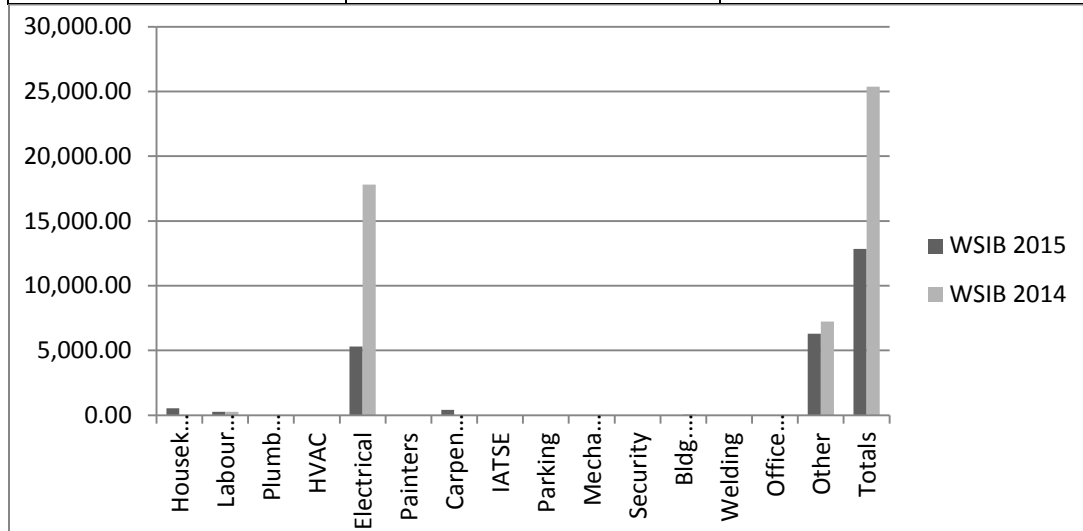
