**Subject: 2010 CNE – Volunteers’/Associates’/Guests’ Privileges**

Summary:

Privileges are extended to various individuals in appreciation for their volunteer service, support and participation in the operation of the annual Canadian National Exhibition.

Financial Implications:

There are no financial implications resulting from the adoption of this report.

Decision History:

The Volunteers’/Associates’/Guests’/Privileges for the 2010 CNE were considered and approved by the Board of Directors of the CNEA at its meeting of May 20, 2010.

Issue Background:

Listed below are the Board of Governors’ privileges for the 2010 CNE which are the same as extended in 2009.

1. Season “Official” Pass (valid for 18-day CNE – admits vehicle, driver and all passengers and provides parking in the Official Lot).
2. Personalized Badge.
3. Single Admission Pass for Governors’ immediate family members.
4. Total of two 18-day Midway Passes
5. Total of two (on request) Air Show Passes to VIP seating.
6. Invitation to the Official Opening Ceremonies.
7. Volunteers’ Lounge

Governors and up to three guests per evening are invited to the "Volunteers' Lounge" (Liberty Grand) which will be opened from 5:30 p.m. to 8:00 p.m. on the following five (5) evenings:

- First Dinner - Monday, August 23<sup>rd</sup>
- Toronto Fire Services Day - Thursday, August 26<sup>th</sup>
- Police Services Day - Monday, August 30<sup>th</sup>
- Toronto Emergency Services Day - Thursday, September 2<sup>nd</sup>
- Friends of the CNE Day - Friday, September 3<sup>rd</sup>

Hosts and their guests will enjoy a "Smorgasbord Buffet" with different hot entrees each evening, accompanied by an array of salads, a variety of breads, dessert, coffee and tea, juice, and soft drinks.

The wait staff will take beverage orders at the tables and serve guests. Hosts are responsible for their own alcoholic beverage charges.

The price of food (inclusive of applicable taxes) is the same as extended in 2006, 2007 and 2009.

- Adults \$ 39.50
- Children (10 years of age and under) \$ 26.00
- 3 years of age and under - NO CHARGE
- Bar (only Beer, Liquor (non-premium), House Wine) \$ 7.00
- Premium Liquor, Liqueurs and Wine by Bottle are at a different price.

Reservations, as in previous years, will be required and coordinated through the Corporate Secretariat.

The hosting Member shall pay the cost in excess of the allowable number of guests and spirits directly to the caterer on the evening attended.
