Hello Arlene,

In follow up of our telephone conversation of this morning I confirm that we at CNSS have no major concerns regarding the proposed Raptor Practice Facility to be located on the grounds of Exhibition Place, save for any loss of parking. With the construction of the hotel across from the Direct Energy Centre and the resulting loss of future net parking and the uncertainty of any future plans for Ontario Place, we feel that the loss of any further parking at Exhibition Place would be as bad for you as it would be for us. We therefore would support the idea of reclaiming the adjacent baseball diamond for parking to offset the parking lost by the proposed Raptor Practice Facility footprint. Unfortunately I will not be in Toronto on August 11<sup>th</sup> or I would have attended the Community Meeting to voice these sentiments. Perhaps you will be kind enough to pass on my views to the Board of Governors of Exhibition Place.
