Financial Impact

Based on a two-year (2014 - 2015) average of 36,370 hours worked, the impact to our operating budget in respect of base wage changes for the next three (3) years will be \$8,072 - 2016; \$8,172 - 2017 and \$8,275 - 2018 which accounts for approximately a 1.25 percent increase annually. This agreement is in line with recent settlements at the City of Toronto and other settlements at Exhibition Place.

The wage package agreed to would see monetary increase of 0 percent for 2016; an increase of 1.25 percent for 2017; an additional increase of 1.25 percent for 2018 and a one-time lump sum payment of \$400.00 for 2016. Other particular changes to provisions are noted in the report. This Agreement renewal was negotiated for a 3 year term.

Financial Impact

Based on the three-year (2016–2018) average of hours worked, the impact on the Operating Budget for each year of the agreement is: \$1,600 for 2016; \$2,861 for 2017; and \$2,881 for 2018. The three year average increase, all costs in, is 0.83 percent.

Beanfield Centre - Building Signage Permit Application

Origin

(March 6, 2017) Report from the Chief Executive Officer, Exhibition Place

Recommendations

The Chief Executive Officer, Exhibition Place recommends that:

1. The Beanfield Agreement expiry date be extended by a period equal to the delay from March 1, 2017 to the day the "Beanfield" letters are installed on the building in all six locations

and the sponsor naming fee also be waived for this same period in 2017.

Summary

The Board has a 10 year agreement with Beanfield Technologies Inc. ("Beanfield") for the naming of "Beanfield Centre" (formerly Allstream Centre) effective March 1, 2017. The naming agreement includes the title sponsorship of the centre, creation of a new logo, venue telecommunication services and building and exterior signage.

The terms of the agreement requires the exterior signage (Beanfield Centre) in 6 locations on the building be installed by March 1, 2017, which term is a major benefit to Beanfield (south and north sides and 4 corners). The change from Allstream Centre to Beanfield Centre involves removing nine letters from the existing signs (Allstream) and replacing them with the new nine letters (Beanfield) and attaching them to the existing engineered support structure with the size and weight of the new letters being the same as the originals.

A similar process was undertaken for the rebranding name change from Direct Energy Centre to Enercare Centre in September 2015 and the permit application for this process and approval by the City Building Department was completed in three months. Accordingly, Exhibition Place staff were working with this time frame. Following approval of City Council of the Agreement on December 13, 14 and 15, 2016, Exhibition Place staff issued an RFP and engaged the consultant / sign manufacturer (WSI Sign Systems Ltd.) on January 17, 2017. The design of the Beanfield letters was completed on February 1, 2017; and the consultant presented its application to the City Building Department on February 14, 2017. City Building Department has refused the application for the main reason that the new requirements of the 2010 Sign By-law as set out in detail below have a major effect on this application and will require a further process for 5 of the 6 locations which the consultant has indicated may take at least 5 months.

Financial Impact

The cost of the additional consultant work and the estimated delay of five months in the payments of the sponsor fee in 2017 will have, at a minimum, a negative financial impact on Exhibition Place Operating Budget of \$183,500.
