Part A: Revision

- 1) The closing for this Request for Quotation has hereby been extended to **Thursday, June 6, 2019 at 12:00:00PM.**
- 2) The Price Schedule has been revised to include Option B for submission, pricing for the replacement and installation of a new living wall system. This is in addition to Option A, the refurbishment of the existing living wall. Please see Appendix A as part of this Addendum for RFQ EPRFQ2019-35070. Bidders must submit pricing for this RFQ on the revised pricing pages to be considered for award.

Part B: Questions and Answers

Q1) Are Bidders being asked to submit pricing for the refurbishment of the existing living wall and pricing for the replacement of the existing wall?

A1) Yes, the Price Schedule has been revised to (see Appendix A as part of this Addendum) request a quote to refurbish the existing living wall and a quote to replace the existing living wall.

Q2) For Section 6. Sub-Contractors, RFQ states that Vendors will be responsible for all sub-contractors. At the site meeting it was mentioned that union trades at Exhibition Place would take on work in their fields with the Vendor Providing shop drawings and coordination of trades. Please clarify if Vendors are sub-contracting Exhibition Place trades?

A2) Section 6, Sub-Contractors is a section outlining the Vendors use of sub-contractors to complete the services requested in this RFQ. This section will apply should the successful bidder make use of sub-contractors to complete work related to this RFQ.

Q3) Please provide the scope of work of the supply and installation of a new living wall?

A3) Please see Appendix A (included in this Addendum) for the scope of work required for the supply and installation of a new living wall.

Q4) Provide the location, diameter and connection of the water line to the living wall?

A4) The location of the water supply to the living wall comes from the Janitor closet in the washroom in Hall D directly behind the living wall. The connection is a one half (1/2") connection.

Q5) Provide the location and type of drain (floor drain? Standpipe?)?

A5) The drain is a floor drain and is located in the Janitor closet in the washroom in Hall D directly behind the living wall.

Q6) Please confirm if the in-board fans are connected to the HVAC?

A6) The in-board fans are not connected to the HVAC system.

Q7) If the in-board fans are connected to the HVAC, is the refurbished system to remain connected to the HVAC system and function as an active biofilter?

A7) There are no plans to alter the current setup and connect to the HVAC system.

Q8) What type of lights are currently installed for the living wall and are they set to a dedicated controller?

A8) Seven (7) Lunar Master Model RT220UB40/230VAC 40 W LED Flood Lights with CCT:5500K; CR180 high purity aluminum reflector, light housing and heat sink die cast aluminum crust. The lights are running twenty four (24) hours a day with no controller for the lights.

Q9) Please confirm that a 4'x4' wall space in the adjacent washroom can be used for installing the irrigation controller?

A9) Yes, the wall space in the adjacent washroom can be used for the irrigation controller.
