Issue Background:

The Volunteers'/Associates'/Guests'/Privileges for the 2008 CNE was considered and approved by the Board of Directors of the CNEA at its meeting of May 22, 2008.

Comments:

Listed below are the Board of Governors' privileges for the 2008 CNE which are the same as extended in 2007.

- 1. Season "Official" Pass (valid for 18-day CNE – admits vehicle, driver and all passengers by way of electronic reading and provides parking in the Official Lot).
- 2. Personalized Badge.
- Single Admission Pass for Governors' immediate family members.
- 4. Total of two 18-day Midway Passes
- 5. Total of two (on request) Air Show Passes to VIP seating.
- 6. Invitation to the Official Opening Ceremonies.
- 7. . Volunteers' Lounge

Governors and up to three guests per evening are invited to the "Volunteers' Lounge" (Gossip Restaurant) which will be opened from 5:30 p.m. to 8:00 p.m. on the following five (5) evenings:

- Ambassador of the Fairs Finals Sunday, August 17th
- Toronto Fire Services Thursday, August 21st
- Police Service Day Monday, August 25th
- Toronto EMS Day Thursday, August 28th
- Friends of the CNE Saturday, August 30th

Hosts and their guests will enjoy a "Smorgasbord Buffet" with a different hot entree each evening, accompanied by an array of salads, a variety of breads, dessert, coffee and tea, juice, and soft drinks.

The wait staff will take beverage orders at the tables and serve guests. Hosts are responsible for their own alcoholic beverage charges.

The price of food (inclusive of applicable taxes) is the same extended in 2007, and the price of spirits has increased by \$1.

- Bar (only Beer, Liquor (non-premium), House Wine)\$ 7.00

The hosting Member shall pay the cost in excess of the allowable number of guests and spirits directly to the caterer on the evening attended.
