

Management Report Month Ending June 30, 2008

Executive Summary

- Net Operating Income for Direct Energy Centre for the six months ending ended June 30, 2008 was \$5,382,214 compared to a budget of \$5,590,142 for an unfavourable variance of (\$207,928).
- Net Operating Loss for Exhibition Place for the six months ending June 30, 2008 was (\$6,530,818) compared to a budgeted loss of (\$7,100,301) for a favourable variance of \$569,483.
- Direct Energy Centre hosted it's annual client event on Wednesday May 28th. Attendees enjoyed
 a great day of networking while raising funds for Sick Kids Foundation.
- The General Manager of Sales & Event Management was a guest speaker at the Green Event Summit in San Francisco on June 13th.
- Sales & Marketing team secured 12 new events, bringing our total to 36.

June Financials Exhibition Place and Direct Energy Centre

Direct Energy Centre

Net Operating Income for Direct Energy Centre for the six months ending ended June 30, 2008 was \$5,382,214 compared to a budget of \$5,590,142 for an unfavourable variance of (\$207,928). Net Operating Income for the month of June only at \$243,328 is favorable to budget by \$46,279 mainly due to additional third party show services.

- Rental income was \$4,763,001 compared to a budget of \$4,907,522 for an unfavourable variance of (\$144,521) mainly due to the timing of new business.
- Electrical services of \$652,085 is favourable to budget by \$41,649 mainly due to the new Hostex event
- Direct and indirect expenses are favourable to budget by \$8,616 as a result of lower show PMD costs.
- Food & Beverage concessions of \$715,118 are unfavourable to budget by (\$96,312) due to timing of new business.
- Telecommunications income at \$258,222 is favourable to budget by \$8,200
- Show services from third party billings are up by \$226,958 with corresponding increase in expenses of \$182,263 for a net favourable variance of \$44,695 mainly due to additional services provided to the Boat show and the new Hostex event.

Direct Energy Centre accounts receivable as at June 30, 2008 was \$937,178 consisting mainly of:

- \$318,774 for services on completed events of which \$30,527 or 9% has been received by July 4, 2008.
- \$185,315 owed as contractual deposits for future events.
- * \$69,554 of Food & Beverage Concessions is owed by Centerplate, of which \$44,957 is contractually due on the 25th of the following month; balance of payment is over 90 days for a November 2007 corporate event has been fully paid as of July 8, 2008.
- \$183,957 for accounts with City Legal; amount fully provided for as a bad debt in the financial statements or the rental income has not been recognized and deferred as appropriate.
- \$83,041 owed for sponsorship arrangement.

Exhibition Place

Net Operating Loss for Exhibition Place for the six months ending June 30, 2008 was (\$6,530,818) compared to a budgeted loss of (\$7,100,301) for a favourable variance of \$569,483. Net Operating Loss for the month of June only at (\$1,088,589) is favorable to budget by \$110,094 mainly due to lower costs for trades.

- Parking revenues at \$,3,059,629 is favourable to budget by \$334,229 mainly due to additional revenues from the Boat show, Interior Design, Hostex, BMO Field and Ricoh events. Parking expenses are up by \$95,275 to reflect the additional revenue stream for a total net positive variance after expenses of \$238,954.
- Tenant income for rent and services at \$1,066,842 is ahead to budget by \$72,271 mainly due to additional show services from Muzik, Medieval Times and Liberty Grand.
- Indirect expenses at \$11,752,724 are favourable to budget by \$71,735 due to lower costs for trades from efficient scheduling offset by higher snow cleaning costs; and higher gas costs.

Exhibition Place accounts receivable for the month ending June 30, 2008 was \$1,881,530 consisting mainly of:

- \$624,990 owed by tenants of which \$99,579 (15%) has been received as of July 4, 2008.
- \$268,946 owed by MLSE for Ricoh Coliseum which \$251,984 (93%) has been received as of July 4, 2008.
- \$226,665 from the Direct Energy Centre for payroll, shared services and utility billings of which all has been received as of July 4, 2008.
- \$192,266 owed by BMO Field for payroll costs.
- \$179,017 owed as contractual deposits for future events of which \$36,677 has been received as of July 4, 2008.
- \$19,351 for show services on completed events of which \$4,840 (25%) has been received as of July 4, 2008.

Sales and Marketing

May/June Sales Effort

Debbie Sanderson and Geoff Mak attended the MPI Toronto Education Conference on June 18-19th, to learn more about the meetings industry and network with industry colleagues. Entering this market is integral to furthering the success of the Exhibition Place Conference Centre. Leads were developed for potential business.

On June 20-24th Don Leddy attended the CAEM conference in Saint Johns, New Brunswick where he participated in two courses towards his CEM designation and had the opportunity to discuss the opening of the new Conference Centre. Don also traveled to Washington DC on June 25th and 26th to attend the Tourism Toronto Sales Mission. A follow-up summary will be presented in the next report.

Upcoming Business Travel

Barbara Outshoorn will be attending the Council of Engineering and Scientific Society Executives in Detroit, Michigan on July 15th to 18th with SMG. A follow-up summary will be presented in the next report.

Publicity

On June 24th after approval from Toronto City Council a multi year sponsorship agreement between MTS Allstream Inc and Exhibition Place was announced. The new conference centre being built within the heritage façade of the former Automotive Building will be named Allstream Centre - A Conference & Convention Centre at Exhibition Place.

The months of May and June were very busy with numerous community events, charity walks and meetings, in addition to several regularly recurring events. Most of these events were very straightforward to bring in and service; everything went well and there were no incidents of note to report.

Staff identified and implemented additional safety measures for runners and vehicles during the YMCA Corporate Team Challenge. These measures are recommended for future years as well.

The first ever Ride to Conquer Cancer took place from Direct Energy Centre and was a huge success. Similarly, the Games Workshop, another first time event, was thrilled to have a much higher patron turn out than anticipated. Several exams and assorted private meetings were held.

Exhibitor Services

During these early summer months, Exhibitor Services is actively preparing for the busy fall show season. Staff is also working on special projects such as creating a photo library of Exhibition Place rental items.

Staff Development

Staff from Event Services and all the Exhibitor Services Staff have been registered to attend computer courses to enhance their work skills.

Canadian Association of Exposition Management Conference

The Director of Event Management Services attended the annual Conference & Trade Show for the Trade and Consumer Show Industry in Saint John, New Brunswick in June. Event producers and suppliers from across Canada attend. The Director presented the new conference centre plans to the industry at a DEC/ Exhibition Place/Centreplate sponsored opening reception. This year's CAEM conference topics included communicating with customers, negotiation skills and the facilities round table meeting.

Parking

May and June parking activity and revenue showed gains over 2007, with the Marlies playing additional home games in May as a result of reaching Round 3 of the playoffs, and BMO Field hosting additional games.

Telecommunications

Telecom has been working with various departments on IT related components including security systems, building automation, camera deployments as well as typical service deployment and maintenance. Telecom / IT is working to try and integrate as many IT-centric functions on the grounds in order to provide increased functionality, cost savings as well as mobile access. An example of mobile access that is being tested includes enabling Building Operators with the ability to make data changes on lighting and HVAC systems using wireless laptops/PDA's. This increased mobile functionality can improve efficiency and enhance the ability of Operators to make time/condition sensitive changes in energy related elements in a more timely and cost effective fashion. Telecommunications is actively working with the various groups responsible for technical items in the new Conference Centre to ensure the facility is integrated technically. With "Allstream" becoming the new naming partner for the Conference Centre, IT/Telecom is excited by the potential of having a full service telecommunications company being available to assist in technical innovations at Exhibition Place.

Building Operations

Capital Works

Capital Works projects are all on schedule. Roof replacement on the West Annex is over 50% completed. The landscaping at east Ontario Bridge, south of the Stanley Barracks, is complete and planting on the east side of the Direct Energy Centre has commenced. All electrical equipment purchase requisitions are complete and the RFQ for electrical switch board replacement in sub X is in progress. The designs and specifications for the masonry retrofit at the Automotive Building are continuing.

Electrical

Electrical maintenance for the month of May and June included checking the Halls for burned out fixtures, checking emergency lighting and removing the water damaged fixture in the Heritage Court staircase. Installation of the receptacle in Centreplate's oil collector was completed and replacement of the receptacle in the Heritage Court snack bar was completed. From DVR to the telecom room 5 cats were The Electrical Department installed a camera in the Direct Energy Centre garage, with the installation of key switches to roll up doors #20 and #40. Monthly PMP's were completed.

Maintenance

Three motors were replaced in the exhaust fans of Heritage Court. There were a couple of leaks corrected in the Months of May and June; leaks from the overhead pipes (V-Taulic) in the underground garage, a roof leak at the west end of Heritage Court were repaired. In the Mid Arch boiler room, insulation was removed, along with asbestos abatement. A major clean up took place at the absorption chiller at the Tri Gen cooling tower. Freezer repairs for Centreplate were completed. A temperature sensor was replaced in the boiler room, along with a leak. Monthly PMP's were completed.

Facility Services

Facility Services are committed to developing safe work practices and continue to implement new procedures. We are in the process of planning, scheduling and coordination of all upcoming summer events

The following projects/activities were completed or are on-going throughout May & June.

- Completed a wash down of the underground garage and are in the process of power washing the exterior of Direct Energy Centre as part of the PMP.
- Received a new (DST6) street sweeper and provided training to workers that use the equipment.
- Completed grounds wide exterior cleaning utilizing our street flusher, sweepers and numerous paper pickers.
- In the process of planning/scheduling various job specific tool box talks.
- Completed CVOR training for necessary licensed vehicle operators.
- specific "New Employee" procedures, ensuring amendments to our orientations/training and testing is completed prior to start of work.
- Planning future training requirements and has implemented a monthly training schedule.
- Provided WHIMIS training to all staff and provided cleaning staff with specific training on chemicals we utilize with our new supplier Morgan Scott.
- Changed all hand soap and paper dispensers throughout our washroom facilities.
- Created a waste diversion presentation giving vision to our present/future goals & objectives.
- Implemented a waste diversion pilot project for the National Home & Green Living shows. The bulk waste left over from both shows was transported to Optimum Waste and separated. The results were favorable as (16.915) tons of waste was recycled out of a possible (27.2) tons, giving us a diversion rate of 62.2%. Previously this would have been sent to the landfill site.
- Coordinators are in the process of providing various cost estimates for the 2008 CNE and planning delivery of services.
- Assisted Parks and Property to prioritize various plantings and daily property maintenance.
- Completed pruning of numerous trees throughout grounds and assist in planting new trees in various areas.
- Continue to schedule operation of the irrigation system and report/monitor various repairs.

- Completed terrazzo diamond grinding at the east end of the Galleria and will complete all staircases after Operations complete structural repairs.
- Completed inventory audits and implemented various counts in the 2009 management / exhibitor price list.
- The Compliance Coordinator completed a grounds wide trip hazard audit and will continue to monitor as repairs are completed.
- John Harlowe attended his second year of Public Assembly Facility Management School, a program organized by the International Association of Assembly Managers Inc.

Service Stars

Saoirse Carson of Canadian Heritage sent an e-mail to Debbie Sanderson; Mary Ellen Gavin; Ron Kostick; and Francesca Leone on May 9th regarding the "Historical Recognition Program 2008" Press Conference which took place on May 9th: "...thank you all very much for your help-last minute help!!! The event was a success & obviously couldn't have happened without all of you. I know there was much rearranging that had to be done and we wanted to say that it was greatly appreciated."

Melissa Greiner of Eva's Initiatives sent an e-mail to Dianne Young on May 30th regarding the assistance Ron Mills provided for the Home for Life Auction; "...Not only was he always willing to help in any way, but his entire office was on board. It was a joy to work with him and I hope that I will have the opportunity to work with him once again. Ron went out of his way to head down to site (35 Strachan) on May 26 to make sure that we had all we needed and that the picnic tables were in order. The tables were clean and moved exactly where we needed them. I need to tell you that my experience working with Ron was a great one. I have been in the events business for over 15 years and Ron was exceptional in putting in effort and care to our needs."

Dianne Young received a letter on May 29th from Ron McGillis, Past Chair, Board of Directors, Ontario Construction Users Council regarding Danny Chui's valuable contribution to the Council: "The Ontario Construction Users Council (OCUC) would like to take this opportunity to express its appreciation for the continued support of you and your organization. Exhibition Place has been a member since 1995. On behalf of the Council, I would like to recognize Mr. Danny Chui who has volunteered on our Board since 1996......we are genuinely appreciative of Danny's efforts and dedication."

Lee Harper sent the following e-mail to Fatima Scagnol on June 16th: "When I was going toward the water on my lunch break today 2 ladies visiting Toronto from Chicago stopped me and were asking a few questions regarding the buildings. When we were done chatting they both said how very impressed they were with the condition of the grounds "clean and very well maintained" and also how beautiful the buildings are. Always nice to hear - so I wanted to share!"

Centerplate

Retail Department

The Highlight of May was Israel at 60; a new event celebrating Israel's 60th birthday which took place in Heritage Court and featured a carnival atmosphere. It was very well attended and slightly exceeded budgeted sales. Our menus were also adjusted to meet the kosher requirements of the show. Olde Spadina was able to help us meet their needs with a diverse kosher menu.

80% of June revenues were the result of the three events; People in Motion, CFA Exams and the Games Workshop. The Games Workshop was a great success, exceeding budgeted sales by \$2K. YMCA and The Ride to Conquer Cancer fell short of expectations, mainly due to guests opting to bring their own snacks and refreshments.

In order to capitalize on the good weather a BBQ concession was opened during the CFA Exams. The guests enjoyed grilled favourites along with cold refreshments on what proved to be a very hot day.

Now that summer has arrived, lighter fare options have became the food of choice. Sandwich and salad sales increased while hot dog sales have declined.

Catering & Sales Department

Centerplate began the month the month of May in partnership with the UJA Federation of Greater Toronto and a local kosher catering company to entertain a host of local community dignitaries with dinner before a large celebration marking Israel's birthday. The birthday celebration brought Canada's Prime Minister to the grounds to deliver a speech to the crowd. Centerplate provided beverage service to the Prime Minister's green room.

The Canadian Manufacturers & Exporters group, a key client of Direct Energy Centre, were treated to a selection of passed hors d' oeuvres including wild mushroom tartlets and seared beef medallions with a horseradish aioli.

The Law Society of Upper Canada administered their annual Barrister Licensing Exams in May. Centerplate provided full day meal service to the exam-room supervisors which began with an early start breakfast. Boxed lunches including a nut-free desert option kept them going during the day long exams.

We ended the month on a high note with Direct Energy Centre's annual client event on May 28th. Centerplate contributed with a sampling station which featured shrimp and scallop ceviche skewers and fresh melon martinis.

The Toronto Heschel School Gala was a successful event. This Kosher buyout event drew 700 guests into Heritage Court for a night of auctions and awards. The Law Society of Upper Canada was also a success and exceeded sales over last year.

June also marked the inaugural and very successful "Cook With The Chef" series. The Royal Agricultural Winter Fair hosted three consecutive events where guests were invited into the kitchen to prepare a three course meal along side Executive Chef Robert Campbell and his team. The excitement was contagious as 30 newly crowned chefs prepared garlic tapenade, succulent beef tenderloin and poached pears with fresh caramel and raspberry sauce. Chef Robert even presented a bottle of his sacred and secret caramel sauce to the chef that he determined to be the most enthusiastic chef in training.

The catering and culinary department also served a delicious Italian inspired meal to delegates from Milan with the Italian Chamber of Commerce. Lunch included Gazpacho soup served in a fresh tomato bowl topped with a goat cheese crustini, crispy skinned salmon with crème fraiche, fresh brewed espresso and a delectable molten chocolate cake. The delegates were delighted and looked forward to collaborating in future years on ICC events.

Outstanding Payables and Liabilities

At its meeting of June 20, 2008, the Board requested information related to any outstanding payables and liabilities against the Board of Governors. Listed on page 17 of this report are all accounts paid over \$50,000. As of June 30, 2008, Exhibition Place staff has no record of any trade or other payables that are outstanding for goods or services that are over 60 days. With respect to and legal claims, staff are consulting with City Legal and will report back in September 2008. Finally, with respect to claims against the Board and the CNEA for personal injuries or damages, all such claims are referred to the City Risk Manager pursuant to the Board's coverage through the City's insurance policy and are managed and settled by the City Risk Manager, on behalf of Exhibition Place and the CNEA.
