This report encompasses all of the payments made on behalf of Canadian National Exhibition Association and Board of Governors for Exhibition Place in the month of January 2006. The total value of all expenditures for these two programs for the month which in January 2006 was \$4,004,937.30 with individual payments of \$50,000.00 totaling \$3,179,311.72 and summarized in Appendix "A".

This report outlines the transactions for the month of January 2006 that have been paid and are a proper charge against the accounts of the Board of Governors of Exhibition Place and the Canadian National Exhibition Association.
