Subject:

Advanced Tent Rental Ltd.

Recommendation:

This report is submitted for the approval of the CNEA Executive Committee, the CNEA Board of Directors and the Board of Governors of Exhibition Place.

It is recommended that the CNEA enter into an agreement with Advanced Tent Rental Ltd. for the 2006 CNE, with an option to renew for 2007, for the provision of rental modular clear-span tent structures, for an amount not to exceed \$40,000.00.

Background:

Pursuant to the CNEA by-laws, agreements require Board approval and if the term exceeds 1 year, requires approval of the Board of Governors of Exhibition Place.

Discussions:

In the spring of 2006 a RFQ was issued through the City of Toronto Purchasing Department for the provision of rental modular clear-span tent structures. Five companies were invited to bid and two responses were received.

Advanced Tent Rental Ltd. was the lowest acceptable bidder that met all of the requirements of the RFQ. The Advanced Tent Rental Ltd. Bid was \$33,083.42, followed by Regal Tent Productions Ltd who submitted a bid of \$36,947.44.

Advanced Tent Rental Ltd. has supplied modular clear-span tent structures to the CNE for a number of years. The firm is exceptionally efficient in erecting these tents and covers and the product provided is always in excellent condition. The level of service and product provided is always of the highest caliber.

Conclusion:

This report recommends entering into an agreement with Advanced Tent Rental Ltd. for the provision of rental tents and covers for the 2006 CNE, with an option to renew for 2007. The 2006 agreement not to exceed \$40,000.00 net of GST.
