## Comments:

Given that City Council at its meeting of September/October 2004 adopted its citizen appointments to Exhibition Place, and that the CNEA at its meeting of October 15, 2004 recommended its appointments to the Board of Governors, which will be considered by City Council in November, the Standing Committee membership of the Board can now be formalized.
