Recommendation:

This report is submitted for the approval of the Executive Committee and the Board of Directors. It is recommended that the CNEA enter into a contract with Eastlea for the provision of Gate Attendants for the 2000 CNE with an option to renew the Agreement for 2001 and 2002.

Background

Prior to 1999 the Association hired its own staff to provide security at the admission gates. In 1999 an "RFP" was issued inviting interested parties to examine and review the gate operations and submit recommendations for organising and controlling the gates. A one year contract was awarded to Eastlea Security who provided a service superior to that which had been experienced in prior years and at a lower cost.

Discussion

Following the success achieved in 1999 an RFP was issued for the provision of the same services for the 2000 CNE. Three submissions were received from Eastlea Security, Outdoor Box Office (O.B.O.) and Initial security (see results tabulated below). The comparison assumes the same level of staffing and takes into account other factors such as uniforms and equipment. Although Eastlea's charges for supervisory staff are slightly higher than those of O.B.O., Eastlea's rates are not increased for overtime or statutory holidays nor does Eastlea charge for management staff. Therefore, when Eastlea's rates are applied to the staffing schedules, Eastlea's charge is considerably less than those of O.B.O. or Initial Security. See Schedule "A" attached.

During the 1999 CNE Eastlea Security and Show Services co-operated fully with the Association to improve efficiency at the gates and effect cost costs savings. It is anticipated that Eastlea will continue to improve upon these efficiencies and ultimately reduce the cost to the Association still further. It is therefore recommended that Eastlea be offered the option to renew this agreement in 2001 and 2002 pending satisfactory performance in each year.

Conclusion

This report recommends engaging Eastlea to provide for and supervise the operations of the gates at the 2000 CNE with an option to extend the agreement for 2001 and 2002 subject to similar terms and conditions as contained in the 1999 agreement.
