Subject: 2002 CNE – Volunteers'/Associates'/Guests' Privileges

### Recommendation:

### Background:

The Volunteers'/Associates'/Guests'/Privileges for the 2002 CNE was presented and approved by the Board of Directors of the CNEA at its meeting of April 25, 2002.

### Discussion:

Listed below are the Board of Governors' privileges for the 2002 CNE.

1. Season "Official" Car Pass with Admission Card (valid for 18-day CNE – admits vehicle, driver and all passengers by way of electronic reading and provides parking in the Official Lot).
2. Personalized Badge.
3. Single Admission Pass for Governors' immediate family members.
4. Total of two 18-day (on request) midway wristbands.
5. Total of two (on request) Air Show admission tickets to VIP seating.
6. Invitation to the Official Opening Ceremony.
  
7. Volunteers' Lounge & Presidential Suite

Governors and up to three guests per evening are invited to the Volunteers' Lounge (Fountain Dining Room) and Presidential Suite on selected evenings, only.

### Summary of the program:

- The Volunteers' Lounge will be opened on designated evenings (schedule to be determined) during the CNE from 5:30 p.m. to 8:00 p.m.

- Members will enjoy a "Smorgasbord Buffet" with a different hot entree each evening, accompanied by an array of salads, a variety of breads, dessert, coffee and tea, juice, and soft drinks.
- The wait staff will take beverage orders at the tables and serve guests. Members are responsible for their own alcoholic beverage charges.
- The Presidential Suite will also be opened and used as a quiet area for Officials to meet their families, guests, and colleagues.
- The price of food for Adults (inclusive of applicable taxes) has increased for 2002. There has not been an increase since 2000 (it was \$37.00) The price of food for Children (inclusive of applicable taxes) as well as the price for alcoholic beverages (excluding applicable taxes) has not increased for 2002.

➤ Adults	\$ 38.50
➤ Children (10 years of age and under)	\$ 25.00
➤ 3 years of age and under - NO CHARGE	
➤ Bar (only Beer, Liquor, House Wine)	\$ 5.00

Liqueurs and Wine by Bottle are at a different price.

- Reservations, as in previous years, will be required and co-ordinated through the Corporate Secretariat. The cost in excess of the allowable number of guests (member and 3 guests) shall be paid by the hosting official directly to the caterer.


Conclusion:
