Subject:

CHIN Pienic 2007

Purpose:

This report recommends terms and conditions for the licence agreement for the 2007 CHIN Picnic.

Financial Implications & Impact Statement:

The terms in this report are in keeping with the 2007 Operating Budget adopted by the Board and a projected rental income from CHIN to the Board of \$38,496, an increase of \$6,187 over 2006 based on the venue rental increase for the 2007 event year.

Recommendation:

It is recommended that the Board enter into a one-year licence agreement with CHIN Radio-TV International ("CHIN") for the CHIN Picnic 2007 on the terms and conditions provided in this report.

Background:

At its meeting in April 2006 the Board approved a report which recommended entering into a one-year licence agreement with CHIN on the same terms and conditions as are contained in this report.

Comments:

Given the importance of the CHIN Picnic to the community and the fact that this is a free event for the citizens of Toronto, the Board and staff have been working with CHIN since 2000 to provide financial support to CHIN by sharing some revenues generated by the event. These have been summarized as follows:

In preparing the budget projections for 2007, staff used the 2002 - 2006 experiences to project total revenues as well as the impact of revenue sharing with CHIN Picnic and met with CHIN to discuss. Therefore, it is recommended that the Board enter into a one-year licence agreement with CHIN on the following financial terms and such other terms and conditions as are contained in the Board's standard licence agreement:

Payment of Rental: The venue rental fees (GST inclusive) incurred by the Licensee outlined in the License Agreement will be payable as follows: 25% (\$10,201.45) with the executed license agreement, 25% (\$10,201.45) on May 5th, and the remaining 50% balance (\$20,402.90) on June 5th. The show services outlined in the Rentals & Services Form is payable ten (10) days in advance of occupancy.

Conclusions:

It is recommended that the Board enter into a one-year licence agreement with CHIN for the 2007 CHIN Picnic on the terms and conditions set out in this report.
