Issue Background:

The Letter of Intent approved by the Board and City Council included the following clause:

"The Board will establish a Stadium Advisory Committee made up of representatives of the Board, the Canadian Soccer Association, Maple Leaf Sports & Entertainment, City of Toronto Parks & Recreation and the Ontario Soccer Association to provide advice to the Board on the Business and operating plan for the stadium on a purely advisory basis. Committee will be co-chaired by a member of the Board and a nominee of the Canadian Soccer Association".

When negotiating the long-term lease the parties anticipated that an Advisory Committee of the Board would be established to provide advice to the Board and to the Board's manager on the Stadium program, specifically the community use of the Stadium.

Decision Background:

At its meeting of September 24, 2007 the Board received a report Board advising that the Corporate Secretary would canvas the Canadian Soccer Association, City of Toronto Parks & Recreation, Maple Leaf Sports & Entertainment and the Ontario Soccer Association to request a nominee. In addition to the Chair of the Board (or his designate), another Board member would be appointed to this Committee and the Corporate Secretary would also be canvassing members of the Board for their interest.

Comments:

As noted above, I will act as Co-Chair with the CSA nominee, however, once the committee establishes its procedures, the designate, Councillor Mark Grimes, will act as Co-Chair. Mr. Rocco Maragna is being recommended given his knowledge and expertise in the sport of soccer.
