- 1. There are several events at Exhibition Place including move in and move out dates when work cannot be done on this project. General Construction Schedule Restrictions are included with this Addendum.

- Q2. Is there space available that can be used for a trailer for storage of supplies and equipment?
- A2. Contractor will be assigned a location for parking a trailer
- Q3. Is an environmental assessment the responsibility of the supplier to complete?
- A3. See part 4 form A and schedule F
- Q4. Is GEO technical reporting and testing required?
- A4. No, this will be decided during construction
- Q5. Will there be any additional drawings provided for the tendering stage?
- A5. No
- Q6. Is there a specific cable supplier that is required to be used?
- A6. See specifications.
- Q7. Do bidders have to have COR?
- A7. Bidders who qualify with experience in similar projects will be considered.
- Q8. What is the total distance of the feeders?
- A8. 1.300 meters
- Q9. How many manholes are there?
- A9. There are 20 manholes.
- Q10. What kind of cables are they?
- A10. They are PILC cables.
- Q11. Is there an allowance for collapsed ducts or asbestos remediation?
- A11. There will be a contingency fund to deal with this.

- A12. 18 of 19 were inspected and found to be in good condition. The 19th is located under TTC tracks and was not inspected.
