Hall A West Corridor and Loading Dock Retrofits, Enercare Centre, Exhibition Place

Please refer to the above Tender documents in your possession and be advised of the following:

**MANDATORY SITE MEETING MARCH 16, 2021 at 9:30 a.m.  
COVID PROTOCOLS IN PLACE FOR THIS MEETING**

In an effort to maximize safety and minimize risk to all in attendance Bidders are required to adhere to the following:

- 1) Complete the Schedule F – App 1 (ix) Covid Contractor Questionnaire posted with the call documents prior to coming to the meeting and bring the form(s) with you. This form must be completed for each of the Bidder's staff who will be in attendance.
- 2) On arrival at site, an Exhibition Place staff will be doing traffic control at the main entrance to the General Services Building, 2 Manitoba Dr., Toronto, M6K 3C3. Only one person will be permitted entry at a time. Once inside the Bidder will hand their Covid Questionnaire to the Exhibition Place Security staff on the desk.
- 3) An Exhibition Place staff will then direct the Bidder to the table where there will be hand sanitizer and the site meeting sign-in sheet. There will be a bag on the table for deposit of business cards. The Bidder will then go outside to wait, or if the weather is inclement will be asked to wait in their vehicle until all have signed in.
- 4) Following sign-in, Bidders will be accompanied by Exhibition Place staff and our consultants to Hall A at the Enercare Centre for a visual tour of the Corridor and Loading Dock areas to be repaired.
- 5) After the areas have been viewed, Bidders will assemble at a safe social distance near the entry to Hall A where a table will have been set up for the consultants to record questions and the answers to them. These will then be summarized into an Addendum to be posted on the Exhibition Place Procurement site.

- 6) Once the meeting is completed Bidders will be escorted out of the Enercare Centre and back to their vehicles.

Safety for Bidders, our staff and consultants is of the utmost importance to Exhibition Place. All may be reassured that Exhibition Place is a GBAC Star certified facility and all areas will be cleaned using this methodology both before and after the mandatory site meeting. There will be hand sanitizer available at both the General Services Building and in the Enercare Centre. Mask use is mandatory for all in attendance. It is recommended that gloves be worn by attendees as an additional safety measure. While on our site Bidder's will have to follow Exhibition Place safety and infection control protocols.
