**Exhibition Place working towards a new 5-year Strategic Plan!**

In August 2021, Exhibition Place initiated the process to develop the next 5-year Strategic Plan for 2022 - 2026. Over the next five months, the strategic planning process will take place to create what will be a renewed and refreshed strategic plan as we look to shaping the future of Exhibition Place. To drive this work forward, the Exhibition Place Board of Governors has engaged Optimus SBR, an Ontario-based consultancy, to guide Exhibition Place through the strategic plan development.

As part of the initial consultation process, engagement sessions have been scheduled with a variety of stakeholders. This includes Exhibition Place's surrounding community, as well as, community members and organizations from across the City. A Public Consultation Meeting has been scheduled on Tuesday, November 2, 6-7:30 pm. The information presented and topics discussed at both the Community Liaison Consultation Meeting and Public Consultation Session will be the same.
